<u>Subject: "Mandatory Public Disclosure" by Remote Pilot TrainingOrganizations regarding scope of authorization</u>

Remote pilot training organizations (RPTOs) and Train the Trainer organizations (TTTs) are authorized byDGCA, upon satisfactorycomplianceof Drone Rules 2021. Further, the applicants are issued with authorization certificates clearly indicating the details regarding authorization number, scope, validity, addresses (organization, base of operations, flying ground), UAS, Simulator etc. Organizations, so authorized, are required to display the authorization certificate in their RPTO, as per the provisions of Drone Training Circular 01 of 2022 for public disclosure.

- 2. However, it has been brought to the notice of this office that candidates intending to become Remote pilot/remote pilot instructors often get misleading information about RPTOs and TTTs authorized by DGCA, their scope of approval, address, infrastructure etc, on various website/social media platforms.
- 3. Therefore, in order to bring transparency and ease of access to essential information to all the stakeholders of the drone ecosystem, it has been decided that Remote Pilot Training Organizations (RPTOs) and Train the Trainer organizations(TTTs)shalldisplayessentialinformation(asperAnnexure-A)on their website/ social media platform (as applicable) as a "Mandatory Public Disclosure", for each of their bases separately.

<u>Subject: Unauthorized use of State Emblem of India along with name of MoCA/DGCA y Remote Pilot Training Organizations</u>

It has been brought to the notice of this office that a few Remote Pilot TrainingOrganizationsareusingtheStateEmblemofIndiaalongwithMinistry of Civil Aviation/Directorate General of Civil Aviation names on various advertisement platforms including social media, for publicity.

- 2. Such use of The State Emblem of India by unauthorized personnel/agencies is a violation of GSR 643 (E) notification dated 04th October 2007. The State Emblem of India can only be used by the Authorities, Officers and Dignitaries mentioned in schedules of GSR 643 (E) notification dated 04th October 2007 (copy enclosed). Remote Pilot Training Organizations and Train the Trainer organizations may use/display certificate of authorization issued by DGCA (with no alterations), towards proof of authorization.
- 3. Action shall be taken against such organizations as per extant, those found in violation of The State Emblem of India (Prohibition of Improper Use) Act, 2005 and GSR 643 (E) notification dated 04th October 2007.
- 4. Stakeholders are advised to refer to the Digital Sky Platform under the subhead training for ascertaining the list of DGCA authorized Remote Pilot Training Organizations and Train the Trainer organizations. Alink of the same is as mentioned below.
